Call for a New York Fair Pay Act

For the 10th consecutive year, the New York State Assembly has failed to pass a pay equity legislative package that would end wage discrimination for New Yorkers.

"For all these years. I have worked with my colleagues in the Assembly to pass pay equity legislation and other bills addressing equality for women," Assemb.

Rhoda S. Jacobs, Brooklyn's 42nd Assembly District representative told Caribbean Life.

"It is unfortunate that in New York State today we still have so many workers who are not earning equal pay for equal work," she said, adding: "That's not in line with New York's commitment to equality, justice and fairness for all of our citizens. The legislative package I co-sponsored and helped pass would finally put an end to unfair pay gaps."

Specifically, the Assembly legislation would make it easier to enforce equal pay regulations and create a state policy to determine and define "comparable work." Additionally, the legislation would: Enact the New York State

Rebel group seeks prime minister's ouster

Tired of what they call the increasing dictatorship of St.Kitts and Nevis Prime Minister Denzil Douglas, a group of six MPs, including members of his own party and government, now say they are ready to get rid of the long-term leader.

Internal opposition to the four-term prime minister's leadership had been simmering for months before it boiled over into open rebellion in recent weeks when Dr. Douglas, 60, one of the Caribbean Community's longest serving prime ministers, fired his long-term deputy and

close friend, Sam Condor and senior minister Timothy Harris from key cabinet and party positions, blaming them for leading protracted efforts to implode his government.

Meanwhile Condor and Harris. along with opposition legislators and an MP from Nevis say they are ready to form a new unity government that would end decades of traditional partisan politics in the federation of about 52,000 people near Antigua, and run its affairs without Douglas at the helm.

Antigua

Vere Bird, the elder brother of former Prime Minister Lester Bird has died at the age of 76.

Bird, the first son of the island's first prime minister Vere Cornwall Bird, died of a heart attack at Dr Joey John's hospital recently.

Bird, an attorney entered politics in 1981 and served as a minister of aviation, information and public service.

He also served as chairman of the Antigua Labor Party (ALP). Public As

Works and Communications Minister he oversaw the reconstruction of the VC Bird International Airport, which was the subject of controversy after it was discovered that he had granted a contract for the construction of a new runway to a company he was a shareholder.

He was later fired after a scandal in which Israeli weapons, sold to Antigua and Barbuda, were found in the hands of the Medellin cartel of Colombian drug smugglers and a report by Sir Bloom-Cooper recommended that he be debarred from holding public office again.

But despite that report, Bird returned to government in 1996 serving as a minister of science, technology and communications and after the 1999 general election, he served as minister of trade, industry, agriculture, lands and fisheries.

The pilots came to pick up Collie's uncle, who had a medical emergency. The victims were trapped inside the burning truck and their bodies were burnt beyond recognition.

The victims are Collie's mother, Edith Collie, 82, sister, Emanate Polowick and her husband, Tina Polowick, a Canadian.

The plane's pilot, co-pilot and

Barbados

Barbados is sending a delegation to the United States for talks with the major

Grenada

The New National Party (NNP) government of Prime Minister Dr. Keith Mitchell promised to quickly reinstate the construction company, during the recent general election campaign and a little more than a month in office, the promise has been

fulfilled. Minister of Communication and Works, Phys-



ical Development, Public Utilities and ICT, Gregory Bowen made the announcement at a recent press conference.

The Kuwaiti Fund suspended disbursement to Grenada last February after the Tillman Thomas NDC government failed to make overdue payments on four loans. Bowen said the government has entered into a new agreement with the Kuwaiti Fund, which allows CCC to resume operations in April 2013. Projects coming on stream include the construction of 10 roads.

Jamaica

The House of Representatives in Jamaica has passed a bill call-

ing for tougher prosecution of those involved in multimillion-dollar lottery scams that have target-

ed mostly elderly Americans.

The governor general is expected soon to sign the bill, which the Senate also passed on March 21. The bill targets advanced fee fraud, identity theft and the use of technology for illegally accessing financial accounts. The bill also prohibits making threats and coercing victims over the phone. Those found guilty could face up to 20 years in prison.

Authorities say at least 30,000 calls are made daily from Jamaica to the U.S. as part of the scams. Suspects usually tell victims they've won millions but must Continued on Page 16



Eager for new foreign worker program

WASHINGTON (AP) — As desperate as unemployed Americans are to find work, there are still some jobs that many would never consider applying for because they are seen as too dirty, too demanding or just plain unappealing.

But employers that struggle to fill those jobs — washing dishes, cleaning hotels, caring for the elderly — could soon get help now that business groups and labor unions have agreed on a plan to allow thousands of new low-skilled foreign workers into the workforce.

The deal, which still needs final agreement from lawmakers, is one of the last major hurdles to completing immigration overhaul legislation this year, one of President Barack Obama's highest priorities. It is expected to be part of a broader measure that would address the status of the 11 million immigrants who either arrived in the U.S. illegally or overstayed their visas.

The new program, called

the "W" visa, is crucial for companies like Medicalodges Inc., a Kansas-based company that wants foreign workers to help run its chain of nursing homes and assisted-living facilities and perform in-home care for the elderly and people with developmental disabilities.

"We've offered signing bonuses, set up tables in grocery stores, sent direct mail, posted job openings on the Web, even laundromats, and it's still not enough to fill positions," said Fred Benjamin, chief operating officer for the company that operates in Kansas, Missouri and Oklahoma.

"It's tough work taking care of people with Alzheimer's and dementia that may strike somebody or scream at people, may be incontinent, have difficulty getting in and out of bed, or need help feeding," he said. "But we believe there are a lot of people from other countries who would gladly take these jobs."

The average salary for nursing assistants is \$9.50 an hour, while licensed practical nurses with at least two years of college training can earn about \$16.50 an hour. But the company says it has little room to increase wages to attract workers because most of the patients they care for receive fixed Medicaid or Medicare payments.

The new W visa program would admit 20,000 low-skilled foreign workers starting in 2015 and could gradually grow up to a cap of 200,000 after five years. The number of visas would fluctuate, depending on unemployment rates, job openings, employer demand and other data.

It would fill a gap in current law, which doesn't give employers a good way to bring in such workers for year-round positions. The existing H-2B visa program for low-wage nonagricul-Continued on Page 25

Sweeping Senate plan for illegals

A bipartisan group of eight United States senators on Tuesday passed a sweeping immigration bill that seeks to legalize the status of an estimated 11 million illegal immigrants, including Caribbean nationals, residing in the U.S.

The bill is also aimed

at reorienting future immigration by bringing Caribbean and other nationals to the U.S. based increasingly on the job skills and personal assets they can offer.

The bill, by four Democrats and four Republicans, is described as the most ambitious effort in at least 26 years to repair, update

and reshape the American immigration system.

But immigration advocates say the part of the bill expected to draw the most controversy is a 13-year pathway to citizenship for immigrants who have been living in the U.S. illegally.

In an effort to make that proposal acceptable

to Republicans who fear it could unleash a new wave of illegal immigration, the senators placed a series of conditions, or triggers, along the pathway, that would require the U.S. Department of Homeland Security to spend as much as US\$6.5 billion over 10

Fair Pay Act to address and enforce pay equity, including broadening equal pay protections to include equivalent jobs, making it unlawful for an employer to discriminate between employees on the basis of gender, race or national origin, and ensuring that traditional female and minority jobs are not undervalued (A.5958);

* Establish a state policy that local political subdivisions ensure equal pay for work of comparable value regardless of sex, race or national origin (A.1729);

* Implement a state policy that compensates employees in state service equally for work of comparable value by eliminating wage inequality for workers due to sex, race or national origin (A.753); and

* Design and publish a report evaluating wage disparities of public employees related to job titles, segregated by the gender, race and/or national origin of employees (A.881).

*The time for pay equity is

now," Jacobs said. "No worker should make less, simply because of their sex, race or national origin."

Jacobs noted that unfair wages lead to unfair and unequal pensions too.

"Our pensions are based on our wages," she said, adding: "Where our wages are less, so too are our pensions and that is not fair and it is not just."

Women in New York make 84 cents for every dollar men earn, creating a substantial yearly pay gap of roughly \$8,275 between men and women working full time in New York State. Further, minority women fare even worse, with African-American women being paid 64 cents and Latina women being paid just 55 cents for every dollar paid to white, non-Hispanic men nationally.

As a group, these full-time working women are paid nearly \$23 billion less every year because of the wage gap. And since over one million households are headed by women, these disparities translate into further inequity, Jacobs noted. Specifically, if a woman in New York was paid equal pay for equal work, she could afford 63 more weeks of groceries; four more months of mortgage and utilities payments; eight more months of rent; or 2,116 additional gallons of gas each year.

"New York is historically a leader in implementing progressive policies, especially when it comes to equality,' Assemb. Jacobs, who serves in the leadership as the assistant speaker, and on the Rules, Ways & Means, Health and Insurance Committees, as well as the Task Force on Women's Issues and the Task Force on New Americans, said. "Pay inequity and inexcusable wage disparities are wrongs we must make right - the sooner the better. It's time to take swift action to make equal pay a reality for all New Yorkers,"mshe added.

of seats in the legislature, the six have written to Governor General Sir Edmund Wickham informing him that they are a united slate and should be recognized as the elected majority in the St.Kitts and Nevis Parliament.

The crisis has hung like a dark cloud over island affairs, especially in St. Kitts where the seat of the federation's government is located. Groups ranging from the Chamber of Commerce

to the church have asked for a quick resolution to the problem even as the six boycotted the presentation of the 2013 budget in parliament in the past week.

"We are part of the federation and we are responsible as the people's representatives to participate in any action which will serve the interest of the people of St. Kitts and Nevis, Harris said, explaining that while he and the others from the opposition have had bitter rivalries in the past, they were always viewed as "opponents worthy of respect," so it should not be that difficult for legislators from different sides to come together and try to form a unity government. Condor shared similar

sentiments saying that forming a patriotic front government should be very easy. "Being part of a unity government is not a problem for me and I believe it is something that the country is demanding. I think the time has come for us to move away from the divisive and destructive politics and to come together," he said.

So far, the governor general has not acted on the request by the now majority to form the government. Douglas, however, went ahead with his budget presentation despite a halfempty Cchamber, noting that "even with the challenges confronting us, this budget is designed to sustain government's role in stimulating and facilitating growth in meaningful partnership with the private sector."

But even as the uncertainty remains, Harris in the past week said he is beginning to fear for his security as he has been the victim of several threats in recent days.

Surge in drug trafficking expected

A top U.S. State Department official, William Brownfield, has predicted that the Caribbean is likely to see a surge in drugtrafficking activity by 2015 as operations out of Central America dwindle due to international crackdown.

Brownfield, assistant secretary of state for international narcotics and law enforcement, said he believes drug traffickers squeezed out of Mexico, Central America and South America will target the Caribbean because it's spacious and allows them to remain undercover and take advantage of weal law enforcement in certain countries.

"We're dealing with 14 different countries spread across a large area," he said adding, "drug traffickers are looking for very

vulnerable holes."

The State Department official was speaking recently during a visit to Puerto Rico, where he met with local and federal authorities to talk in part about the Caribbean Basin Initiative, which aims to boost regional security with

U.S. funding. In the upcoming fiscal year, Congress has allocated US\$40 million for the program. The new funds will be available by August and distributed after the top priorities are identified, according to Brownfield.

Jamaican dollar plunges in value

On a visit to Jamaica a few years ago, comedian Steve Harvey joked about a loaf of bread costing him J\$100. On his return home, he often joked about what seemed an exorbitant price to pay for the combination of flour and water.

If the radio and television talkshow host travels to the island today, he will have to fork over J\$250 in dough to pay for that same baked product.

And while that might not impose any hardship to the U.S., millionaire or tourists visiting the island, Jamaicans are feeling the pinch of seeing their currency devalued...again.

Early this week, the value of the Jamaican dollar plummeted against the American dollar.

The alarm went off to many hearing that the value was \$99.57. However, by the middle of the week economists described the amount with suspicion saying that the amount parallels the figure set by the International

Monetary Fund - the lending institution the Jamaica government petitioned for assistance. Only 43 cents shy of the number referred to as the "magical benchmark" the IMF had set, some believed the devaluation might have been orchestrated to facilitate the application for a US\$2billion bailout from the central bank leaders.

"I believe it is more than coincidental," an outspoken critic said of the financial plunge.

He expressed the view that there might have been an unstated pre-conditionality of the IMF for the Jamaican dollar to reach a new low of J\$100 to US\$1 before an agreement was signed with the Fund.

However, financial analyst Colin Bullock said he had no basis to conclude that the IMF wanted the Jamaican dollar to slide to its present value.

One of the conditions of an IMF loan is that the borrowing Continued on Page 24

U.S. judge backtracks in Haiti's PM defamation case

MIAMI (AP) - A federal judge in Florida is backtracking on a ruling that barred a Haitian-American journalist from writing about Haiti's prime minister, who had sued the reporter for defamation.

U.S. District Judge Ursula Ungaro reversed course in a ruling Tuesday, lifting the prohibition. Ungaro also ordered Prime Minister Laurent Lamothe and South Florida businessman Patrice Baker to file an amended complaint detailing facts that support their allegations that Leo Joseph's reporting was false or made with reckless disregard for the truth.

The attorneys representing Lamothe and Baker did not immediately respond to messages left Thursday by The Associated Press. They have until April 19 to file the amended complaint.


"The ruling was in everyone's favor," said Joseph's attorney, Scott Ponce. "The First Amendment says you can't have an order prohibiting you from speaking on a subject. It was an important ruling to get the prior restraint set aside."

Ungaro had issued a default ruling in February in favor of Lamothe and Baker, who sued Joseph in federal court in September over his reporting for the New Yorkbased Haiti-Observateur.

The lawsuit said Joseph had published false and malicious reports about Lamothe's role in the sale of a telecommunications company. Ungaro initially said she agreed with Lamothe and Baker, and she also prohibited Joseph from ever again writing about either man in their professional, personal or political lives.

Lamothe and Baker had asked Ungaro for a default judgment because Joseph failed to enter a plea or otherwise respond to the lawsuit.

On Tuesday, Ungaro wrote that the plaintiffs must provide evidence to support taking the extraordinary step of banning Joseph from ever again writing about Lamothe and Baker.

As Washington lawmakers throw themselves into comprehensive immigration reform, I say, "Remember the women."

Women constitute more than half of our country's undocumented immigrant population. They have a huge stake in the new immigration overhaul now being crafted by eight men in the Senate.

Undocumented mothers, especially, are making history by advocating for comprehensive immigration reform. I saw them at the Capitol last week, testifying before Congress. They spoke of husbands serving in the military and children hoping to attend college. Maybe they were afraid, but they conquered their fear and testified.

Most immigrant women are law-abiding. Their only illegal act was entering the United States without a visa. They are grateful to be here and believe in giving back. They respect authority. They're active in their schools and churches, and are role models of civic engagement. I know this because many

States with at least one undocumented parent; 73 percent of these children are citizens. Yet more than 200,000 parents of U.S. citizens were deported in the past two years. Children not born here risk deportation, too. For immigrant women, maintaining family unity is their highest priority.

Women deserve a rapid path to residency and citizenship. Rapid means 3-8 years, not 10, as the Senate is proposing. Most undocumented women already have been here at least 10 years -- paying taxes, raising children and working. They need to be sanctioned quickly so they can work, study and participate fully in American society, just as their children are striving to do.

Women need flexible ways to document their residency in the U.S. Many women have sporadic work histories, are paid under the table and have no consistent proof of employment. Many stay home, caring for young children. These

Small business opposes global firms' tax avoidance

In our highly partisan environment there seems to be very few issues that Republicans, Independents and Democrats agree on. This partisanship is easily seen in Congress but is also alive with voters across the country. Small business owners are often no different than their customers in demonstrating divergent opinions on issues depending on their political preferences.

So when we find an issue on which small business owners agree, regardless of partisan leanings, we should take notice. And when that agreement centers on one of them most contentious matters that Congress will soon be addressing, our elected officials in Washington need to pay close attention. Such is the case involving federal tax fairness between small business and large, multinational corporations.

Small business owners are keenly aware that multinational corporations are legally escaping paying much, and often all, of the highly publicized 35 percent U.S. corporate income tax rate. In a poll released early last year by the American Sustainable Business Council (ASBC) and others 80 percent of the small business owners surveyed said that U.S. multinational corporations using accounting loopholes to shift their U.S. profits to offshore tax havens is a problem. Seventy-five percent said that big corporations using tax loopholes harms their own small business.

Accounts of giant businesses like Boeing, General Electric, Pfizer, Microsoft and Honeywell International using offshore tax loopholes to dramatically lower their taxes – often to zero -- are all too common. U.S. Public Interest Research Group just released report showing that each of America's small businesses on average picks up the tab for \$3,067 to cover the costs of tax avoidance by U.S multinational corporations playing the offshore profit-shifting game.

It is clear to small business owners that the ability of these large corporations to minimize their tax liability through offshore tax loopholes is contributing to our nation's budget problems and is harmful to the small business community. This awareness of multinationals shirking their tax responsibility has resulted in a bipartisan small-business owner consensus on the need of large, multinational corporations to pay their fair share of taxes.

Last month ASBC and the Main Street Alliance (MSA) commissioned a scientific telephone survey of over 500 small businesses across the country. As national business organizations represent-Continued on Page 12

Defying the people easy for Capitol misfits

There are some things we can readily identify as solid barometers of what "civil" society was meant to be. This 100th anniversary of the introduction of the federal income tax furnishes us with one of them. A recent Pew Research Center survey was reassuring in its finding that 71 percent of respondents believed Americans had a moral obligation to report income earned. By the same token, though, much of the gloss comes off that image of wholesomeness and doing the civic thing right when, again on the matter of taxes, a reported 258 Capitol Hill lawmakers remain signatories to the pledge Grover Norquist demanded of them, not to raise taxes. Safe to say Norquist must think he still has a pretty good ransom deal going.

The only redeeming value about the latter item is that the 258 members of the House and Senate could be dismissed as mere commodities for sale on the open market who therefore can't hold a candle to a scientifically derived 71 percent of the population. The people, in other words, displaying a readiness for their designated role that puts to shame the sad, spineless conduct of their elected representatives. Not unlike the sickening tableau now unfolding on the gun control issue – the shame of better than 90 percent of the country favoring something (background checks) and some really noxious types in the Congress in open defiance of that reality.

Frankly, we would have thought there was enough of a hullabaloo over raising tax revenue during the "fiscal cliff" and "sequester" episodes for most of the Capitol Hill misfits still hog-tied by Norquist's "enforcer" tactics to become emboldened enough to jettison his tax pledge demagoguery. That 258 of the 535 members of the House and Senate find validity or are sufficiently intimidated to subscribe to the town cry of a charlatan is sobering commentary on the descent of political representation into travesty.

Norquist famously declared that he wanted to shrink government down to a size that "it could be drowned in a bathtub." It's the kind of fist-pumping line guaranteed to get a rise out of a gathering of small-government believers. But it's one thing revving up an audience of simpletons with rhetoric about "getting government off our backs" and other loaded appeals to crowd hysteria. It's a whole other matter to reel in folks charged with lawmak-



ing responsibility and have them, too, parroting nonsense about government having no right to the citizenry's monetary contribution to facilitate the state's proper functioning.

It's incredulous that the merchandisers of this tripe can so effortlessly get some among the masses walking in lock step with the notion that there is precious little that a government has to do. How the full spectrum of government services impacting people's lives somehow becomes, for some, a non-factor in society's overall design is mind-boggling. One would tend to narrow the purveyors of this malarkey to those with malicious intent to mislead the gullible and others incomprehensibly trapped in some foggy existence. Whatever the breakdown among those pushing the anti-tax agenda, it's comforting to know that it's a view the average Joe doesn't share - something borne out by the Pew study. Only 12 percent among those


surveyed said they disliked paying taxes because they didn't approve of how the government spent tax dollars.

Not unexpectedly, scapegoating gets into the picture somewhere. And in the diatribe about too much government, the scapegoat of choice is entitlements...which one can't realistically examine absent the not-well-disguised class warfare inferences that attend it. An honest attempt at reforming government entitlements is hardly deserving of summary rejection, given today's fiscal challenges. What's not cool is what underlies the din from the right where "reform" in truth means gutting to the point of imperiling the well being of those on the lower rungs. It's about folks indicating what, given the opportunity, they would do to those whose pushback is deemed to pose no threat. Some people in Britain may have been over-the-top coarse in their reaction to the passing of Margaret Thatcher, but their protest/celebration last week was basically a gut response to someone who dared to unapologetically present herself as no friend of the underclass.

Then there's always this paradox of those beating the loudest drum

against government spending invariably being the biggest cheerleaders for costly military action, justified or not. When George Bush, Dick Cheney and a bunch of trigger-happy neoconservatives were hell bent on that unnecessary intervention in Iraq 10 years ago, there was nary a suggestion from these armchair gladiators that a tax be imposed to fund the war (God forbid it be a tax on the well-to-do). So there's our takeaway from that particular military miscue: government is for engaging in ill-advised battlefield abominations; not for helping citizens lead productive lives.

The disconnect continues. On issue after issue we find too many of the people's representatives in Washington standing some place remote from vox populi. Which, as we've said here before, makes no sense at all. Why else are they there if not, foremost, to be reflective of the views of those they supposedly represent? "In America the people govern," Benjamin Franklin once said, early in the American narrative. Some folks evidently didn't get that memo. It needs to be sent again, for starters to the 258 lily-livered toadies of a modern-day medicine man named Norquist.

Continued from page 10 factors need to be considered in legislation dealing with proof of residency.

Women need their families acknowledged, regardless of marital status. Many undocumented women are not formally married to their partners. Immigration reform must include both unmarried and samesex partners who face special persecution in their home countries.

Women need the freedom and safety to come out of the shadows. Because they fear deportation and separation, undocumented mothers remain in the margins of American society. They do not report domestic violence, rapes, work exploitation or other crimes against them. Without documents, they cannot realize their full potential to work as professionals. They're discouraged from furthering their education.

Freedom from fear

includes freedom from the threat of detention and deportation, which is ripping apart families in every state. Detention of low-risk families should be frozen and reviewed. America can only benefit by helping undocumented mothers gain rapid citizenship. They are the glue to their families and communities. They volunteer in their children's classrooms, attend PTA meetings, raise money for schools, and help their kids with homework. They study English. They work. One of my best students works the graveyard shift at a fast food place, then comes home, gets her kids off to school, and attends my three-hour English class. Sometimes her eyes droop, yes, but she is motivated by her children. Her top English goal, she said, is to be able to talk with her child's teacher and help with homework.

Some say undocument-

ed women should go to "the end of the line," behind those who've applied legally. This policy would affect poor women and children disproportionately, and punish women who risked life and limb to enter the U.S. These mothers were too poor to apply for visas, and knew they could never get a legal visa precisely because they are poor. Residency and citizenship for undocumented mothers will restore and strengthen families. Most of the immigrant women I know have not seen the Statue of Liberty. But each day they show how much they value her. Now is their time.

Continued from page 10 ing small and medium size companies, both ASBC and MSA have advocated for equitable taxation on big business profits to invest in the country's infrastructure and address the national debt.

Here are some of the overwhelmingly bipartisan consensus results of that ASBC/MSA small-business owner poll just released.

• More than three quarters of small business owners support closing overseas tax loopholes with a unitary combined reporting system:

75 percent or more of Republican, Independent and Democratic small business owners support this approach, which is successfully used by states to stop corporations from shifting the location of profits to avoid taxes.

• More than four out of five small business owners oppose a proposal to institute a territorial tax system (a system that would eliminate U.S. taxes on profits made or shifted offshore):

85 percent of small business owners oppose a proposal for a territorial tax system. Across party lines, at least 67 percent strongly oppose the proposal.

• Small business owners support ending deferral of taxes on foreign profits and requiring US corporations to pay income taxes on income earned overseas:

When asked if foreign earnings of U.S. corpora-

tions should be taxed after given credit for foreign taxes paid, 64 percent of small business owners expressed support. Within each party affiliation, at least 62 percent, expressed support.

These results should send a clear signal to Congress and the president from the country's small business owners. The priority for reforming our nation's tax code is to stop multinational corporations from using offshore tax havens to avoid paying their fair share of taxes.



Each side blames the other for Venezuela violence

CARACAS, Venezuela (AP) — All day, the political heirs of Hugo Chavez filled Venezuela's airways with a steady drumbeat of attacks on the man who says they stole the presidency from him. They called opposition leader Henrique Capriles a coup-plotter and said he was inciting post-election violence that had claimed seven lives and injured 61.

President-elect Nicolas Maduro further charged Tuesday that the violence was being bankrolled and directed by the United States, which said it wouldn't recognize his victory without a vote-by-vote recount demanded by Capriles.

It was not clear, however, whether the violence was as serious as Chavez's anointed successor claimed. Venezuela has an average of more than 40 homicides daily, one of the highest rates in the world, and the government offered almost no information on the deaths that Maduro blamed on "neo-Nazi gangs."

Capriles called the government assault a smoke screen to divert attention from his demand for a recount of every ballot from Sunday's election, which the National Electoral Council said Madu-

ro won by 262,000 votes out of 14.9 million cast.

A number of opposition protests across Venezuela have turned violent, but apparently only after National Guard riot troops and police used tear gas and plastic pellets to turn back marchers converging on provincial offices of the electoral council.

While government officials complained of violence by Capriles' supporters, incidents of intimidation by gangs of pro-government forces, some armed, also occurred.

An Associated Press journalist witnessed a pro-government gang of motorcycle toughs rampage through Teques, seat of the state that Capriles governs. They tossed a firebomb into an opposition party office and smashed display cases and looted goods from a bakery they said was owned by a Capriles supporter.

In the western town of San Francisco in Zulia state, three journalists with the local newspaper La Verdad said they were arrested by motorcycle-borne National Guard troops and jailed overnight Monday because they had interviewed a family that the troops had harassed. Reporter Juan Jose Faria wrote that the troop's commander told the reporters the country was in the midst of a coup and that they were putschists.

Maduro accused opposition protesters of attacking government health clinics, a socialist party office and the house of electoral council President Tibisay Lucena on Monday, but the government provided no details. Like Chavez, Maduro has a history of making allegations he does not substantiate.

Meanwhile, Maduro's government announced that 15 countries had confirmed they were sending high-level delegations to Maduro's swearing-in on Friday. They included Bolivia, Ecuador, Nicaragua, Iran, China, Saudi Arabia, Qatar, Haiti, Uruguay and Argentina.

The potential for violent street confrontations in the capital Wednesday seemed to be headed off when Capriles called off a planned march to electoral council headquarters. That decision came after Maduro urged his supporters to take to Caracas' streets at the same time.

"Whoever goes out into the street tomorrow is playing the government's game," Capriles said at a news conference. "The government wants there to be deaths in the country."

first wire payments to cover taxes before they can receive the prize. The scams generate at least J\$300 million a year.

St. Kitts

St. Kitts and Nevis has established diplomatic relations with Paraguay. The relevant documents were signed recently by Organi-

zation of America States (OAS) ambassador/ permanent representative Jacinth Henry-Martin on behalf of St. Kitts and Nevis and Martin Sannemann for Paraguay.

Henry-Martin said this is an important step to deepen existing bonds of friendship, paving the way for more focused attention to collaboration in areas of mutual interest.

These range from language instruction, information and technology exchange in the area of small farming and agricultural development to tourism and cultural exchange.

Permanent Secretary in the St. Kitts and Nevis Ministry of Foreign Sffairs, Elvis Newton, said this move represents another component of the government's efforts to form strategic relationships with countries in order to promote mutual interests in the international arena.

Suriname

A Haitian "bush" doctor is facing a manslaughter charge after one of his "patients" died after drinking a concoction aimed at healing his illness.

Police said Hosner Guerrier, 42, also a Haitian national had been taken to the "doctor" by his relatives after he complained of feeling unwell. But he died soon after he was given the "medicine" to drink.

When the officers arrived at the location in Kwatta, a residential area in west Paramaribo, they found the victim's lifeless body, according to a statement by the police.

Police said they recovered the drink the "doctor" gave his "patient" adding that they man could be charged with manslaughter.

Two other people, including the "doctor's" assistant, were questioned by police.

for her alleged role in the 2005 kidnapping and subsequent murder of her lover retired U.S. war veteran, 62-year-old Balram "Balo" Maharaj of Mount Vermont, New York.

According to the U.S. Embassy, in Port of Spain, Dooren Alexander-Durity, 47, appeared before Judge Deborah A Robinson in



the District Court of Colombia on April 2, 2013 on a two-count indictment filed in September 2010.

She is accused of organizing the kidnapping of Maharaj when he visited his native country in 2005.

It is alleged that she arranged to have him kidnapped from a bar in San Juan a few miles from Port of Spain. The plot went awry and the Army veteran was shot to death. Twelve other co-conspirators from Trinidad were extradited and prosecuted by the U.S. Attorney's Office for the District of Colombia. They are waiting to be sentenced. If convicted, Alexander-Durity faces a maximum penalty of life imprisonment.

She has previously denied the allegations and fought extradition since 2006.

THE CARIBBEAN BUSINESS REPORT Guyanese women grow sorrel for export

By Tangerine Clarke

Long Creek farm on the Linden/Soesdyke Highway in Guvana. is the site of a government-, and businessfunded Quick Impact project to encourage women to grow sorrel for export.

On a recent visit to the farm, project director Dr. Faith Harding said the farmers will begin to earn money from the first harvest of some 400 tons of dried sorrel expected from seedlings donated by the Mexican overnment.

Several initiatives were put in place as part of the Quick Impact program that includes scholarships and job-placement opportunities in rural areas where sorrel can flourish on fertile land. The plant was not grown for commercial benfits, but for local consumption only, especially during the Christmas season, but could be specially cultivated to meet growing demand around the world, because of its medicinal properties for curing hypertension, diabetes and other illnesses.

"I discovered that sorrel could be picked four times a year," said Dr. Harding, who explored the market before initiating the pilot project with 30 farmers, who cleared 10 acres of land, r planting an initial 600 seeds which pro-

duced some 5,000 plants.

Now, farms are littered with thousands of the red buds and doing quite well, Dr. Harding said, but cautioned that raising funds was crucial. The program received assistance from

the National Agriculture Research & Extension Institute (NAREI), but the needs more resources.

"We must raise funds for an irrigation system for the Long Creek farm," she said, adding: "The yield has

not been as good as we had hoped, but we gained experience, and have been able to ship a few pounds as an sample, to show the Mexico Agricultural agency our progress."

"We have applied to the

Ministry of Agriculture for further assistance and are awaiting approval," Dr. Harding said, adding that the farms at Moraikobai, Mahaicony Creek, are producing very well but not at the projected yield, while the Cor-

riverton, Berbice group has germinated over 4000 seeds which were recently transplanted.

"We're making every effort to plant at least 400 acres of sorrel (which would) yield the 400 tons required by Mexico," she added, but cautioned that 400 acres in Guyana is but "a drop in the ocean," and would take "a whole lot of energy and other resources to bring this young nation's people to produce like their lives depended on it."

Michael, a resident and project manager at Long Creek, recalled thatJamaicans were some of the first farmers in the region to cultivate farmland with pineapples in the '70s. He noted that the sandy soil in the area poses a challenge to the crop and suggested that a "drip system" would have to be put in place to water the plants.

"There's a variety of sorrel, that include the Spider, Mexican and Jamaican varieties which could produce bountiful crops," he said.

Juanita Melville, leader of the women farmers, said: "The best idea is for us to secure an international market. Sorrel has come to Guyana and Long Creek, where it will be available all year long, but I would like to see more women involved," she added.

Returning to normalcy after a cancer diagnosis

(StatePoint) Cancer. It's a word no one wants to hear, yet all too many people are diagnosed each year. With a diagnosis comes many questions, most importantly how to get the best medical care possible. For many, the next logical question is how to maintain a normal life with cancer -including balancing work, life and health demands.

Nearly 80 percent of cancer patients and survivors say continuing work after diagnosis aids recovery, according to recently released survey results from nonprofit organization Cancer and Careers and Harris Interactive. Still, many struggle to find support navigating the work/life balance of employment with cancer.

Survey results showed that several factors motivate cancer survivors to continue working ---

• Before sharing your diagnosis, study your options. Learn about the laws that may protect you, know your company's policies and speak to your healthcare team.

• Be mindful of what you say online. Whatever you post becomes part of your online brand, so consider the short- and long-term effects of what you say and do.

• When returning to work, ease back into the routine. Make sure vou take care of yourself physically and mentally.

• Be clear with your co-workers about how they can support you.

• Be prepared to "swivel" the conversation back to work-related things so the focus isn't always on cancer.

• Rely on free resources to help make the transition. For example, Cancer and Careers pro-



nation must be "willing to forfeit some of their sovereign authority" in order to prevent a collapse from the global economy. Another condition is that the IMF will also provide advice on methods to improve the Jamaican economy.

By providing the two billion rescue fund, the IMF will help secure the Jamaican currency and encourage stability in the financial sector.

The Jamaican dollar lost 12 percent of its value in the last year and a whopping four percent since the government outlined a deal with the IMF on Ash Wednesday.

"Right now, when mi a buy snack for my daughter, it's no less than J\$2,000. It's because mi have a discount card why I get it for this price," a mother told the local newspaper. "It's just by the mercies of God mi survive but it could be worse. God is taking care of me and my family."

Those days, she recalled, were in the 1980s and during that period trading of the Jamaican currency did not escalate beyond the J\$6.50 to US\$1 mark.

And at that time a great many protested even recording dance songs named "Everything Crash."

"Three thousand-odd dollars and mi nuh get half a weh mi want yet," another national lamented. "Mi did waan three sardines and a only one mi could afford. You nuh see seh the country mash up?"

Tourism can benefit

Hotels charge their visitors in U.S. dollars while most of their costs are paid in Jamaica dollars. Hotel owners pay wages, utilities and taxes in Jamaican dollars.

Reportedly, one-third

of Jamaican households live on US\$ remittances received from family members in the U.S.

When the Jamaican dollar slides, transfers by Money Gram or Western Union gain extended value.

With inflation running at nine percent and cuts in services, citizens may have to brace for more than a pinch. Allegedly, planned spending on national security is down by four percent. The police training budget was reportedly snipped. Education spending has also been slashed by five percent.

Reportedly, China will lend Jamaica approximately 20 percent of their capital budget. Terms for repayment of the US\$300 million loan will be spread over a much longer period than the IMF amount. Those funds will allegedly be used for a major infrastructure development project.

Continued from Page 3 tural workers is capped at 66,000 per year and applies only to seasonal or temporary jobs.

If other temporary worker programs are any indication, most of the foreign workers taking advantage of the new W-visa program would come from Mexico, Jamaica and Guatemala. About 80 percent of workers in the H-2B visa program in 2011 were from Mexico, according to State Department data.

^{*}It's not perfect, but it's probably as good as it can reasonably be to make both sides happy in a way that protects the interests of U.S. workers while also bringing workers in when employers truly need them, not just when they say they need them," said Daniel Costa, immigration policy analyst at the liberal-leaning Economic Policy Institute.

Labor unions have criticized other temporary worker programs, claiming that businesses don't look hard enough for American workers to fill the jobs and that foreign workers depress U.S. wages and have no chance for advancement. But unions made sure more protections were built into the new program.

The number of workers admitted each year would fluctuate based on actual employer needs determined by a new federal bureau to monitor the job market. Workers would earn the same wages paid to U.S. workers or the prevailing wages for the industry they're working in, whichever is higher. And it would allow foreign workers to move from employer to employer, petition for permanent residency after a year, and eventually seek U.S. citizenship.

Not all business groups are pleased with the deal. Several major construction industry groups issued a statement criticizing the agreement for limiting the number of visas for construction workers to 15,000.

"A guest worker program that fails to provide a sufficient number of visas to meet market demand as the construction sector recovers will inevitably make it harder to fill critical labor openings," said a statement from Associated Builders and Contractors, the National Association of Home Builders and other groups.

Labor unions, worried about members losing jobs to foreign workers, argued that construction should be treated differently from other industries because it can be more seasonal in nature and includes a number of higherskilled trades.

But the agreement is seen as a boon to employers in long-term care, the hotel and restaurant industry and other low-wage service sectors that are among the fastestgrowing job categories in the nation. Seven of the 10 largest occupations in the country now pay less than \$30,000 a year, according to the Bureau of Labor Statistics.

Continued from Page 3 years to increase enforcement and extend fencing along the Southwest border.

According to the bill, the border security programs would have to be fully operational before any immigrant, who had been in the U.S. illegally, would be able to apply for permanency, or green card, the first step toward becoming American citizens.

The bill includes a long list of "disqualifiers" that prevent Caribbean and other immigrants from becoming legal residents if they have any felony convictions or at least three misdemeanor convictions.

Illegal immigrants also would not be able to upgrade their status if they were ever convicted of a criminal offense under foreign law, voted unlawfully in the United States or are

determined by the federal government to be a criminal, or national security or

public health threat.

"There are serious civil rights concerns," said Cecillia Wang, director of the American Civil Liberties Union's (ACLU) Immigrants' Rights Project. "There shouldn't be any kind of automatic disqualifiers."


But Sen. Charles Schumer (D-NY), one of the bipartisan "Gang of Eight" who wrote the legislation, said the bill strikes the right balance.

"If the ACLU drew up their bill, it wouldn't pass the Senate," he said. "We've made it clear, if you commit a serious crime, you shouldn't be on the path to citizenship."

After meeting with Schumer and Sen. John McCain (R-AZ), President Barack Obama hailed the legislation as "largely consistent" with the principles he had laid out for sweeping immigration overhaul.

He said the provisions in the bill are "all commonsense steps that the majority of Americans support.

"This bill is clearly a compromise, and no one will get everything they wanted, including me," he said. "But it is largely consistent with the principles that I have repeatedly laid out for comprehensive reform."

BOOK REVIEW Relationships in the African-American community

The song always pops up when you least expect it.

There you are, minding your own business, you hear a few notes, and you're pulled back to a wonderful-horrible time, starry dreams, laughter, bitterness, love lost. That old love song might be just a "precious melody," but it almost brings you to your knees.

Love is such a complicated

thing: easy to fall into and easy to fall out. And in the new anthology "Where Did Our Love Go," edited by Gil L. Robertson IV, you'll see that you're not alone in being alone.

The statistics are quite sobering.

Forty-two percent of Black women ages 25-34 are unmarried. The number is similar for Black men, higher for those over age 34. African Americans simply are not keeping pace, marriagewise, with their white counterparts.

But why? Is it a legacy of slavery, a cultural issue, "being picky," or economic fall-out? Or is marriage historically "ill-suited" for people of color?

Perhaps, as one writer hypothesizes, relationship woes could be an issue because many young Blacks have never "actually seen... one family unit consisting of a father and mother, plus two children." Or maybe the timing for marriage was wrong, as another believes. There's too much judgment, too much "craziness," too much self-reliance from too early an age.

And it gets even more complicated.

The old "there aren't enough decent black men to go around" is bunk. Malcolm X proved it wrong, though many continue to believe it. Black men often think black women only want someone equal or better, financially, and how can they play against that? Black women consider "swirling." Neither can talk about what they really want. Aunty Vie celebrates 100 yrs

Viola Shaw certainly deserved the lavish celebration of a special church service at St. Sidwell's Anglican Church and four parties in Georgetown, Guyana to honor her on her 100th birthday on April 17.

Viola was born during the peak of British rule in Guyana. She outlived presidents and prime ministers, and had the pleasure of seeing her country become independent, and then a Republic nation.

But this feisty old lady with an encyclopedic brain isn't done yet. There is no doubt Viola has many more years to enjoy her guilty pleasures of ice cream, Mac & Cheese and pastries.

Lovingly called Aunt Vie, this cute little lady who loves to tell stories of years gone by, was born on April 17, 1918 in the rural area of New Amsterdam, on the Berbice Coast.

She may have lived to be 100 years old, but it was not easy getting to where she is today. As she sat in her comfortable room at the Holy Family Homestead in Georgetown, where she still knits and cooks, Aunt Vie recalled how hard she worked, but never regretted it. She attributes her active lifestyle and kindness to others, as qualities that brought her to this day in her life.

"I was very kind to people, this is the reason I had a long life. I also prayed to the almighty," said Aunt Vie, who asked God for strength, good health, and long life.

After her mother died when she was just two years old, Viola's father took on the role of both parents, but eventually had to send his two daughters to live with a family friend.

"I was treated like a servant. I had to carry a heavy basket on my head from the market, and was forced to do manual labor in the house," recalls Viola, who said she got up at the 'gong' of 5:00 a.m, and did not go to bed until the 'gong' of 8:00 p.m."

However, Viola was even-

tually able to break free and used the skills she had acquired to become a domestic worker in several homes, including a wealthy British Caucasian couple, who treated her very well.

At the age of 23, Viola married a poultry farmer and enjoyed her life as a housewife, but left her husband years after he became an alcoholic.

She never had any kids of her own, but she enjoyed the company of nieces and nephews who looked after her, especially she said, her adopted niece Lillieth Clemonds, who took her (aunt Vie) into her home, after a family member had evicted her.

This centenarian who still has a lot of energy and spring in her step, says she likes solitary moments, and even though she claims not to be too talkative, she surely had lots to say about living to be 100 years old.

Time to check your passports

As the summer season approaches, New York Passport Agency Customer Services Manager Robyn J. Richards is calling on families to check expiration dates on their passports.

In an exclusive statement to Caribbean Life, Richards reminds the traveling public that passports issued to minors under age 16 are only valid for five years, rather than the regular 10 years for adults.

She noted that some countries require an entry visa that may take several weeks to process, and with the summer season being such a busy time for travel, she suggested that citizens take the opportunity to equip themselves with all valid travel documents.

"Apply early for your passport," said Richards, who advised travelers to avoid waiting in line as well as saving \$60 for an expedited book. U.S. citizens must present a valid passport book when entering the country by air.

Those entering the Unites States from Canada, Mexico, the Caribbean and Bermuda at land borders and sea ports must present either a passport book, passport card or other travel document approved by the U.S. government.

Scores will Reflect New Emphasis on College and Career over Basic Skills

There's something uncommon taking place in the city's public schools.

Schools Chancellor Dennis Walcott responds to parents' questions

Why are my child's tests getting harder? As a parent, I'm tired of hearing that this is going to be great for my kid.

Let's be honest. Tougher tests aren't the problem. The real problem is that too many of our kids aren't prepared to succeed in college or flourish in a career. We're not doing them any favors if we don't challenge them. It's time we raised the bar.

The new curriculum demands that your kids engage their creativity and intellectual curiosity. The goal is



to take them beyond the pages of their textbooks and prepare them for the real world.

The new tests will reflect that richer—and more challenging—coursework. When you set a new goal for yourself that feels out of reach, you work harder to meet it. This will be no different. And that's a good thing.

Why am I hearing that my child's test scores are going to drop?

There's no way to know how your child will do until he or she takes the test. But we're now measuring based on completely different, and tougher, criteria. The last tests measured basic skills. The new tests measure your child's ability to get into college or learn a skill after high school graduation.

Some states that have adopted the Common Core have seen lower test scores of over 30 points at first. We have



set new benchmarks in the past and our students have always risen to meet them and we think that over time they will do the same with these new standards.

I'm struggling to support my children with their homework. How can I help my child master the more challenging coursework?

We get that. We've worked hard to develop vast parent resources for you. 
On the heels of his new album, Harlem-Kingston Express:Live and now in his 51st year as a musician, Jamaican-born Alexander is In high demand with performances that has him globetrotting and cityhopping.

Orisha drummers to perform in City

By William Farrington

A rare opportunity presents itself this week as Orisha drummers play Manhattan's Elebash Hall. Outside of Trinidad, Orisha is generally experienced in late-night gatherings in Flatbush churches celebrating feasts, occasions which can last several nights. Earl Noel, a master of this sacred ceremonial tradition, will lead a trio of drummers and an ensemble of dancers in an Orisha religious service. Three drums, the Bo, Bembe, and Umele are at the center of the ceremony. The drummers call to each Deity in turn with a particular rhythm known by that Deity's name.

In a sense, Earl says, it's a conversation with that spirit or ancestor -- the rhythms from the three

drums calling the Yoruba deities; a tradition handed down orally from generation to generation that he continues as a drummer and teacher in Brooklyn.

A typical Orisha religious service includes Spiritual Baptist hymns, plaintive prayers, lively songs for all the spirits, and closes with a somber Continued on Page 34

Continued from page 33 song of thanks. All of the songs are sung in Yoruba, except for the opening hymns sung in English, says producer Ryan Bazinet

A musician, Ryan fell in love with the fast-paced, energetic music, where everyone is singing and clapping. "It is the best feeling and musical experience i have ever had." The Orisha religion shares roots, Yoruba lyrics and even identical songs with the Cuban music," he says. "Many people who have heard of Santeria did not know Yoruba-derived music and religion exist in Trinidad. I am thrilled to be a part of sharing this with a wider audience."

Earl plays a vital role in the Orisha social scene in Brooklyn, which is coming into season. As the weather gets warmer, feasts return, centered at Mt Moriah Baptist and other churches in Flatbush.

Earl began drumming at four years old in Belmont, Port of Spain. "A place called Gonzalez," he says. The youngest of 13 children, he was born into Orisha music, first picked up drumming from his older siblings and from his neighbor, Mother Burness, the keeper of the Orisha feasts there. He now spends time teaching drumming -- folkloric and Orisha, to youths here in Brooklyn. Natural Expressions, another group he is involved in performs during carnival season and includes drummers of all ages.

While Orisha music remains largely confined to tight-knit communities both here and in Trinidad, its influences can be heard in the popular music of David Rudder and in the spiritual folk music of songs like, "Bring Down the Power" by Ella Andall.

Historian and radio host Trevor Wilkins says "Shango (Orisha) played a serious role in Trinidad and Tobago music in the '30's and '40's, calypso grew out of shango and spiritual baptist music. The pracitice itself was banned under colonial rule, and as an underground practice only became legal with independence." Chalkdust, Sparrow, Houdini and others made calypsos based on Shango.

The concert is Wednesday, April 24 at Elebash Hall, located

Eccentric artist lobbies for inmate's freedom

"Herman's House" Very Good (3 stars) Unrated Running time: 81 minutes Distributor: First Run Features Herman's House

Seventy-two-year-old Herman Wallace has been imprisoned at Louisiana's infamous Angola penitentiary since he was found guilty of committing bank robbery back in 1967. His sentence was later lengthened to life after he was convicted of stabbing a prison guard to death solely on the testimony of a fellow inmate.

Was he a political prisoner who'd been railroaded on account of his membership in the Black Panther Party, or had he actually committed the murder? Unfortunately, that question is not the focus of "Herman's House," an unlikelycouple documentary directed by Angad Singh Bhalia.

Mr. Singh instead devotes his attention to the friendship forged between Herman and a woman half his age. "Jailbirds and the naïve girls who love them" has served as the theme of many a TV talk show, but rarely have any gangsters' molls had the pedigree, sophistication or undying dedication of Jackie Sumell.

Sumell, an activist who once presented antiabortion President Bush a guilt woven from hun-

dreds of pro-choice feminist's pubic hair, was a grad student in the Art Department at Stanford when she took an interest in Herman. What really rankled her was the fact that he held the record for solitary confinement in the country, currently

at 40+ years and counting.

Over that period, he's been cooped up in a 6×9 foot cell, which Jackie felt was a violation of the 8th Amendment's sanction against cruel and unusual punishment. So, she struck up a long-distance correspondence with Herman via a combination of letters and phone calls.

And that led to a decision to draw attention to his plight by mounting an art exhibition featuring a full-scale replica of his prison cell. But this is where it gets weird. She also asked Herman what his dream home would look like, prior to then moving down to New Orleans, buying some land, and consulting architects to draw up plans for a place the two would ostensibly share should he ever be paroled.

Listen, this biopic basically revolves around Jackie's earnest effort to turn Herman into a cause célèbre, but it carefully tiptoes around the more compelling elephant in the tiny cell, namely, whether there's a roman-

tic aspect to their relationship? A fascinating flick as much about a possible miscarriage of justice as about a case of arrested development who looks like a little girl playing house with an imaginary mate.





The FIFA Goal Projects are an initiative to build stadiums and administrative buildings in under-developed countries and in other areas in need of expansion.

In the Dominican Republic, that nation's soccer federation's president, Osiris Guzman, led the delegation on visits to past Goal Project initiatives such as the Joseph Blatter Technical Center and the new Pan-American Soccer Stadium. The group also visited the future site of the next FIFA Goal Project, where a futsal field will be built.

The female athletes comprise: Adero Dasilva, Casanique Richardson, Lenesha Olliver, Narisia Young and Kerina Hooper (ISSAC Intermediate Female Champion 2012. SVG representative at CARIFTA 2013 and member of the 2012 Penn Relays team).

Godfrey "Fuzzy" Harry is the head coach, Kamal Hunte, assistant coach, and Teacher Dawana Balcombe is the manager/chaperone.

Marlon Samuels gets Wisden recognition

West Indies all-rounder Marlon Samuels received the prestigious recognition from Wisden as one of its five Cricketers of the Year. One of the highlights of the vear for Samuels was his terrific innings of 78 from 56 balls that led West Indies to win the ICC World Twenty20 Title. In three Tests in England, he batted five innings and failed to pass 50 runs only once. He went on to Bangladesh and scored his highest Test score of 260. He scored 866 runs including three centuries and four 50s in seven Test matches at an average of 53.27 last year.

Barbados Protests Exclusion From Semi-Finals

Barbados and Combined Campuses and Colleges (CCC) finished fourth on 10 points but Barbados was not chosen as one of the four teams for the semi-finals. Barbados lost to CCC in the head to head contest and in spite of Barbados having a better net run rate of 0.013 compared



with CCC 0.055, the West Indies Cricket Board left the team out. Both Barbados and CCC ended with two wins from their six games.

WICB Super 50 Tournament Rules

According to the tournament rules, if two teams end the competition on the same number of points, the team with the more wins will secure the semi-finals spot. If the teams are still equal, the rule states that "the team with the most number of wins over the other team or teams who are equal on points and have the same number of wins will be used as a factor to determine which team goes through to the semi-finals. Consideration is also given to the the team having the highest

number of bonus points and the final criteria is the team with the highest run rate.

Barbados Cricket Association Goes to Court

Conde Riley, first vice president of the Barbados Cricket Association said "there is an error with regard to the final standings. In any Round Robin Tournament, individual teams will win and lose and the tie breaker used internationally is the net run rate if most wins cannot determine the positions." Prominent attorney at law Randall Belgrave, QC, is representing the Barbados Cricket Association in this matter. The final for Regional Super 50 championship is set for Sunday April 21 at Kensington Oval, Barbados.
